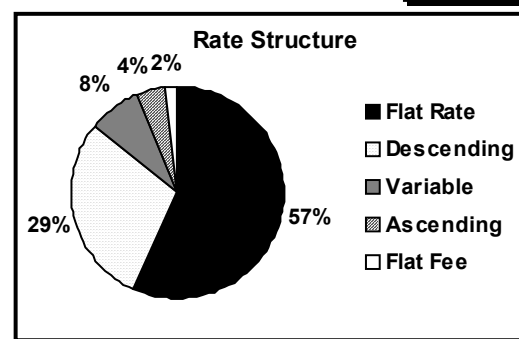
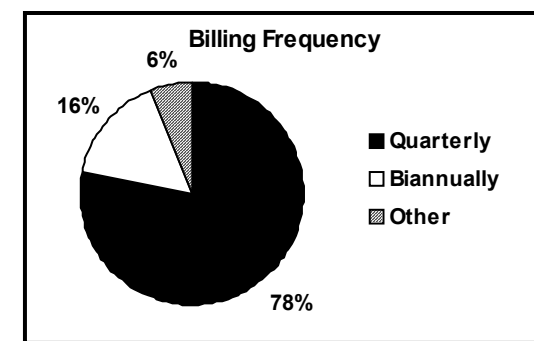
Tighe & Bond is pleased to publish our “2003 Water Rate Survey” for water suppliers in Connecticut. Our survey is limited to systems serving a population of 500 or greater. The survey incorporates available information from the following sources:

- written survey responses
- CT Department of Public Utility Control (DPUC) Website
- US Environmental Protection Agency Website – Envirofacts Safe Drinking Water Information
- websites of water suppliers
- our 2001 Water Rate Survey

About 58% of the drinking water suppliers responding to our survey use surface water as their primary water source, with the remaining 42% relying on groundwater sources.

A variety of water rate structures are used in Connecticut. Based on the written survey results, 57% of water suppliers use a flat or uniform rate structure; 29% use a descending rate structure; 8% use a variable rate structure; 4% use an ascending rate structure; and only 2% use a flat fee. To allow for a comparative analysis, we have calculated the “typical” yearly homeowner’s cost assuming consumption of 96 hundred cubic feet (72,000 gallons) per year. Based on the information included in this survey, typical annual water costs in Connecticut range from a low of \$129 per household to a high of \$590. The 2003 average is \$278 per household.

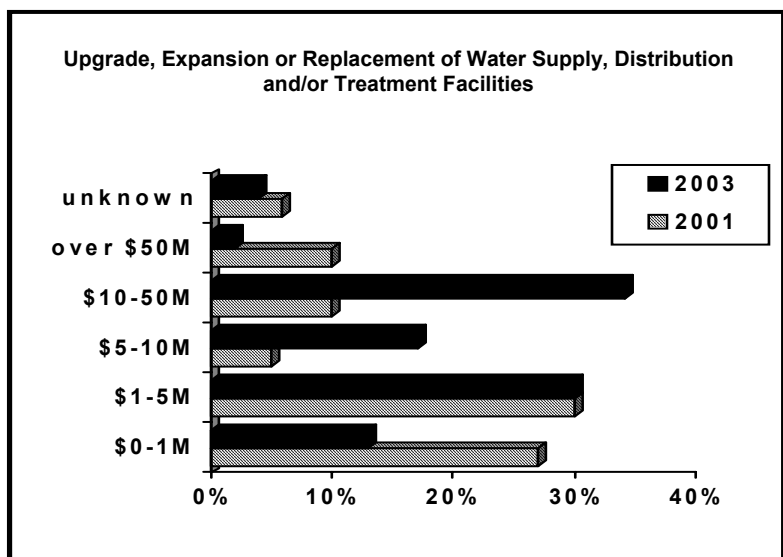
The majority of respondents use a quarterly billing cycle (78%). Sixteen percent use a biannual billing cycle, and the remaining 6% use either an annual, monthly, or tri-annual cycle.
